#### Brief Background:

Bombay Rayon Fashions Limited, the Corporate Debtor, having CIN L17120MH1992PLC066880 was incorporated on 21 May 1992 under the Companies Act 1956, as a public company limited by shares with the Registrar of Companies, Mumbai, Maharashtra. Its registered office is located at Office Space Number - 06B123, WeWork Raheja Platinum, Sag baug Road, Off Andheri Kurla Road, Andheri East Marol Naka, Mumbai, Mumbai, Maharashtra, India, 400059.

BRFL is a textile company, engaged in the manufacture of a wide range of fabrics from state-of-the-art production facilities. BRFL is known for its excellent yarn dyed fabric, printing, finishing, processing, weaving and garment accessories viz., buttons, labels, elastic, etc.

#### Listing Status:

Listed on the National Stock Exchange of India Limited, the Bombay Stock Exchange and the MCX Stock Exchange. The listing is currently suspended.

#### Insolvency Proceedings:

Mr. Vikash Parasprampuria sole proprietor of Charanjilal Yarn Traders, in its capacity as the operational creditor of M/s Bombay Rayon Fashions Limited (the 'Corporate Debtor') filed an application under Section 9 of the Insolvency and Bankruptcy Code, 2016 (IBC) before the Hon'ble National Company Law Tribunal (NCLT), Mumbai, for initiation of Corporate Insolvency Resolution Process (CIRP) against the Corporate Debtor.

The Hon'ble NCLT, Mumbai Bench admitted the aforesaid application vide its order dated 07.06.2022 and appointed Mr. Santanu T Ray as Interim Resolution Professional (IRP) for conducting the CIRP in the matter of the Corporate Debtor.

Later, at the first meeting of the CoC dated 26 July 2022, the CoC approved the appointment of the Resolution Professional of the Corporate Debtor. The appointment of Mr. Satish Kumar Gupta as the Resolution Professional was approved by the NCLT by an order dated 4 August 2022. In accordance with Section 23 of the IBC, the powers of the board of directors of the BRFL are suspended and such powers are vested with the RP.

During 20th CoC meeting held on 29th August, 2023, the Resolution plan had been put to vote which had been rejected by the Committee of Creditors of the Corporate Debtor. Consequently, an application had been filed for the liquidation of the corporate Debtor on 29.09.2023 which had been allowed by the Hon'ble NCLT, Mumbai Bench, vide its order dated 09.11.2023 (received on 10<sup>th</sup> November, 2023) and appointed M/s Truvisory Insolvency Professionals Private Limited as liquidator of the Corporate Debtor.

## Status of Liquidation Process:

The Liquidation proceedings commenced vide NCLT order dated 9<sup>th</sup> November, 2023 (received on 10<sup>th</sup> November, 2023) and public notice was issued on 13<sup>th</sup> November, 2023. The claims were required to be submitted by the financial creditors, operational creditors, claims from workers and employees and other claimants, if any by 9<sup>th</sup> December, 2023.

All the claims received were verified, accepted, or rejected on the basis of the documents provided by the respective claimants in order to substantiate its claim and/or to the extent the records received by the Liquidator from the Corporate Debtor, as the case may be. The valuation process as required by IBC is completed. Since Hon'ble NCLT has directed the undersigned to sale assets of the company thus accordingly this EOI has been issued.

Further, it is pertinent to note that both the Secured Financial Creditors i.e., JM Financial Asset Reconstruction Company Limited and Axis Bank has partially relinquished its security and the Assets which are not relinquished are separately sold by the lenders under SARFAESI.

## Sale of Corporate Debtor as a Going Concern:

On August 8, 2024, an E-Auction was conducted for the sale of the assets of the Corporate Debtor, Bombay Rayon Fashions Limited, having Corporate Identification Number (CIN) L17120MH1992PLC066880, as a going concern. This sale excluded certain specified assets which were not relinquished by the Secured Financial Creditors. Furthermore, the Liquidator successfully completed the sale of the Corporate Debtor as a going concern excluding certain assets and has received full consideration from the successful bidder.
